DEVELOPERS MOVE IN ON FISHBOURNE

A firm of developers who claim in their website to help their clients "keep ahead of the game" are targeting Bethwines Farm as a suitable location for substantial new building in Fishbourne.

The initial bids are for 25/75 houses but one developer has said in his published objection to the District's draft Local Plan that the whole farm should be used for new houses. Many readers will remember 2008, when the village successfully fought off an attempt to build 200 houses on the site.

Until our Neighbourhood Plan and Chichester District's Local Plan are approved, the key document for building applications is the National Panning Policy Framework (NPPF). It says clearly that "The purpose of the planning system is to contribute to the achievement of sustainable development." The site is not included in the draft Fishbourne Neighbourhood Plan 2014-2029 because it is not considered sustainable.

At its January meeting, Fishbourne Parish Council unanimously objected to any housing development on Bethwines Farm, arguing that this would not be "sustainable development" on the following grounds:

- 1. The location of the site is outside the Settlement Policy Area.
- 2. Development of high quality agricultural land when poorer quality land is available elsewhere runs counter to the NPPF.
- 3. Para 80 of the NPPF clearly states that planning should prevent neighbouring towns and villages "from merging into one another".
- 4. It would have an adverse impact of the development on Chichester Harbour's designation as a European Habitats Directive Site for overwintering birds.
- 5. It would intensify the traffic problems on the A259 and the Fishbourne roundabout.
- 6. It would increase the rat-run dangers associated with traffic on Salthill Road and Clay Lane, particularly during the morning and afternoon school runs.
- 7. Flooding is already a perennial problem in Fishbourne as the village is low-lying and, because of five decades of development with no improvement in infrastructure, the existing infrastructure already struggles to cope with twice the original demand.

Fishbourne Neighbourhood Watch needs you...

There is someone suspicious in the area... garden sheds are being broken in to at night, cars are being damaged... How can you help yourself, your neighbours and other residents in Fishbourne?

I am trying to set up a complete Neighbourhood Watch network for the whole of Fishbourne.

At present there are 5 people, points of contact, serving 5 roads/areas:

Blackboy Lane (North), Roman Way/Dolphin Close/Gilpin Close, Halfrey Road/Halfrey Close, Godwin Way and Creek End.

If you live in the above roads but do not know your point of contact please contact me and I'll put you in touch. If you live outside these areas, let's face it – most of us do – and would like to be part of the Neighbourhood Watch scheme contact me for more information.

There are about 30 other roads not in the scheme!

To be a point of contact for a particular road you will be responsible for forwarding emails to others in your road and informing those without email addresses by telephone/letter. It's as simple as that! All it takes is a few minutes each week.


If you are part of a **Residents Association** perhaps you would include Neighbourhood Watch for your members.

Among the many responses, the Environment Agency, Southern Water and English Heritage have been particularly helpful with technical information which is relevant to our local situation. We've also had helpful advice from the planning, historic environment, economic development and housing teams at Chichester District Council. As a result, we think we have a plan that expresses what the community wants in a way that is considerably strengthened.


We are about to enter the more challenging stages! The independent examiner has to assess how far the "basic conditions" of the Town and Country Planning Act 1990 have been met and whether the plan is compatible with "EU obligations". It's another world from the Village Survey which started off the whole process! However, it's essential we get all the technicalities right because examiners are not slow to fail neighbourhood plans. So for the next month or so we shall be wading through bureaucracy to make sure we get everything right! It will all be worth it.

FROM VISION TO REALITY. For the rest of the year, five task groups, each led by a member of the Parish Council, will help to change the vision of the Plan into practical projects which will improve the quality of life in our village. **And that's where you can get involved!**
