Fishbourne Village Survey - Analysis Results 2023

Introduction

Number of responses

1200 forms were delivered to each home in the Village and additional forms were available at 3 locations; Fishbourne Primary School, Fishbourne Centre and The Woolpack Pub. From which, 183 responses were received.

This corresponds to a 15.3% return, which is lower than previous years, 30% in 2018 and 22% in 2013.

Regarding the age of respondents, the 2021 census shows that only 31% of residents were over 60 years old, however, 71.4% of survey respondents were over 60 years old. This suggests that the survey results may not be a fair reflection of the Village feelings but it is a true reflection of those who did respond.

In 2018, an online survey was also carried out which accounted for 26% of the total responses but this was not done in 2023.




1. LAND ALLOCATION

Question 1.1 – Bearing in mind that we have a target allocation of 30, please rank the following options as first choice or second where 1 is your preferred option;

A number of small-scale developments to make up a total of 30 dwellings 1st = 153, 2nd = 23



A single development of 30 dwellings $1^{st} = 24, 2^{nd} = 146$




Analysis indicates that over 90% answered the question and overwhelmingly preferred a number of small scale developments over one single development of 30 homes.


Question 1.2 Which types of property are now required in the Parish? Respondents were asked to tick the relevant answer;







2 - 3 Bedrooms







3 to 4 bedrooms









Analysis of the results indicates that only 80% of respondents felt able to answer the question with 17 respondents making a comment similar to "Don't know how many homes of each type now so don't know how many we need"

Of the 80% who responded, flats, rentals, larger properties and social housing were all considered to be "about right".


Almost 70% said there were too many holiday homes.

Over half of respondents wanted more 2 and 3 bed homes and homes for the elderly. This was reenforced by 6 comments indicating they wanted "Housing for older people / sheltered / smaller"


6 respondents noted in comments that they wanted to see more "Part buy / part rent homes or affordable homes"

Question 1.3 Eco friendly housing. With the need for a reduction in carbon emissions, the Parish Council has adopted a Climate Change action Plan to work with organisations and residents to reduce carbon emissions. Respondents were asked how far they agreed with each of the statements:


All planning applications should provide evidence of how they have been designed to minimise climate impact

Site plans should include an indication of the charging plans for electric vehicles




Analysis indicates that the majority of respondents agreed with all statements, with slightly less wanting electric charging points to be included in developments. However, 34 respondents noted in comments that they favoured "ECO and / or sustainable homes which reduce carbon footprint"


2. **DESIGN**

"In further support of our concern that new buildings should be attractive places that people are pleased to live in and proud to call home, we propose adding two extra requirements in the Design Section." Respondents were asked to indicate how far they supported each of the two new requirements:

We are developing the concept of "good design" in Fishbourne since this is the key aspect of sustainable development, creates better places in which to live & work and helps make development acceptable to communities



In order to encourage a creative approach, we will not attempt to impose any one style or taste.



Analysis indicates that the majority agreed with both new requirements.


However, 10 respondents noted that "'Good Design' is subjective or personal" and cannot be predetermined.

3 respondents asked that design should "Ensure reasonable garden sizes"


3. THE ENVIRONMENT

We intend adding a new policy on Climate Change. Respondents were asked to show how far they agreed with the statements:

The Parish Council should encourage and support all groups and individuals who are attempting to reduce their carbon footprint.



For all building applications we should set the highest possible standards for energy efficiency, onsite use of renewable energy and water efficiency that are achievable without impacting on the commercial viability of the development



We should explore schemes to decarbonise existing homes through energy efficiency and on-site renewable energy generation, including grant-funded improvements

Analysis indicates that almost 90% of respondents were supportive of all 3 statements.

Further, 5 respondents noted that it is possible to "Mitigate climate change by encouraging and / or supporting environmentally sound design housing plans"


Additionally, 6 respondents noted that we could "Encourage planning applications which offer eco ideas and / or provide local grants for existing homes to become more environmental"


3 respondents felt it was either not relevant or not important to consider the "Impact on commercial viability"


Speed of traffic







Noise of traffic





Volume of traffic






Increasing size & weight of vehicles





Use of local roads & lanes to avoid Fishbourne roundabout






Analysis indicates that over 80% of respondents were greatly concerned about the speed, volume, size and weight of traffic along with great concern for use of local roads as a means to avoid the Fishbourne Roundabout. However, only 64% were greatly concerned about traffic noise with a further 30% undecided about the level of concern for this noise.

Several comments re-enforced the concern for the speed, weight of traffic and for the issues associated with the Fishbourne Roundabout and access to and from the roundabout.



If Fishbourne became eligible for 20mph, would you like to see the new limit in;




Salthill Road






Clay Lane (Salthill Rd - Blackboy Ln)


Clay Lane (Salthill Rd - Hanah Place)







Analysis, indicates that over 80% of respondents agree that the Village needs an evidence based Traffic Plan for the village with 15% being undecided.

Regarding the possibility of 20mph on various roads throughout the Village, circa 60% of respondents wanted the 20mph to cover each of Blackboy Lane, Salthill Rd, Clay Lane east to Blackboy Lane and Clay Lane west towards Hannah Place, Old Park Lane, Mill Close and Mill Lane.

For the A259, almost equal numbers (41% and 42%) of respondents agreed and disagreed with 20mph on the A259 with 17% unsure.

Only 47% wanted 20mph for Appuldram Lane South, with 20% disagreeing and a third being undecided.


Additional comments were as follows:


- Support re-enforced for 20mph (26)
- Disagreement with any implementation of 20mph (15)
- Desire for better enforcement of 30mph and / or signage (12)
- Request for better traffic calming measures and / or Village Gates (9)
- Concern that A259 was the alternative route for the A27 so should / could not be 20mph (4)

5. GREEN SPACES

The designation of Local Green Spaces through Neighbourhood Plan enables communities to protect green spaces which are of particular importance to them, because for example, their beauty, historical significance, recreational value including as playing fields, tranquillity or richness of wildlife. The respondents were asked to indicate how strongly they agreed with the statement:

In our present Neighbourhood Plan we have listed Fishbourne Playing Field, Fishbourne Meadows, the green spaces at the entrance to Roman Way and those at the entrance to Creek End. Should we transfer these to FNP2?





Analysis shows that 88% agreed that the listed green spaces should be transferred to FNP2, with 12% undecided. There were however, 16 comments asking "what is FNP2?"

Respondents were asked to make further suggestions for Green Spaces and the following ideas were put forward, the numbers in brackets, indicate the number of times the same or very similar suggestion was made:

- Land between Deeside Ave & Clay Lane (2)
- All verges & banks (2)
- Fields along Clay Lane West (1)
- Area around The Mill Pond (2)
- Water course in Fishbourne from Salthill Rd to playing fields (1)
- Area around Roman Palace (1)
- Paths and entrance to Deeside Ave (3)
- Deeside oval green (2)
- Creek End Village Green (1)
- A community Garden / orchard /allotments (2)
- Bethwines Farm fields (8)
- Creek area to west of the Church (2)
- Knott Gardens grassed area (1)
- The 2 fields opposite Roman Palace by school (2)
- Verges at entrance to Mill Close (1)

6. SENSE OF COMMUNITY, INVOLVEMENT IN DECISION MAKING AND COMMUNICATIONS

- 6.1 Strategies to develop awareness of a sense of community and the involvement of a higher proportion of the community in the decision making process. Respondents were asked to make comments about the following statements:
- In developing a sense of community, this project will pay particular attention to the isolated and the vulnerable including continued support for Fishbourne Companions, for the establishment of Men's Sheds, for a Warm Hub at the Fishbourne Centre and the healthy opportunities for all ages at the Fishbourne Paying Fields.
- Younger members of the community will benefit from support for the extension of the Pre-School, a contribution to the Running Track around the Primary School Grounds; developments in the Play Area equipment on the Playing Fields.
- We will develop more Task Groups involving members of the Community.
