DISTRICT COUNCIL MATTERS HIGHLIGHTS

Grant Funding

The Council has issued more than £220,000 to businesses and community groups from the UK Shared Prosperity Fund (UKSPF) and the Rural England Prosperity Fund (REPF). This is from the £1.7 million that we were allocated in 2022

Money from the UKSPF is there to help encourage economic growth and improve the quality of life for people across the district, while the REPF is intended to support projects which assist with supporting businesses and community infrastructure to address the challenges faced by rural areas

Harbour

Cabinet have given the go ahead to bid for government money so that our coastal engineering service can develop a plan for the Chichester Harbour area that will help communities prepare for flooding and coastal change. The plan would also help to protect and restore the harbour's habitats and ecosystems.

Midhurst

It is just over a year since the major fire in Midhurst. As you know, the council has stepped in to offer significant support to the town with a package of over £300,000, as well as business support on the ground and marketing activities to encourage people back to the town. The funding has been used to provide grants to eligible businesses, pay for a new website to promote the town and to provide coaching from a retail specialist. The Town Team is also developing a new Midhurst Business Partnership. The Council will continue to support Midhurst.

Growth and Place

Novium Museum

An exciting new exhibition will be roaring into The Novium Museum this summer. 'Dinosaurs: Hungry Hatchlings' showcases how even the largest dinosaurs started life as eggs and tiny hatchlings.

Policy

The Government has recently published consultations on changes to the planning system to provide 'An accelerated planning system'. The consultation seeks to speed up decision making by changing performance criteria; reducing the use of extension of time agreements; potentially introducing requirements to determine major commercial schemes within 10 weeks; and widening the use of the fast-track appeal route to reduce the number of appeals considered through written representations. The council's response will be considered by the Planning Committee on 17 April 2024. Changes to postal vote handling and secrecy These provisions will be in effect for polls taking place from 2 May 2024.

- 1. Ban on political campaigners handling postal votes
- 2. Limits on handing in postal votes at polling stations
- 3. Completion of postal vote documents form
- 4. Postal votes which are 'left behind'
- 5. Handing in postal votes to the Returning Officer
- 6. Secrecy requirements extended to postal and proxy votes
